Dear Sir,

Please refer to our DO letter of even number dated 12/05/2020 requesting to widely publicize Bureau's Massive Open Online Course (MOOC) Platform on Cyber Crime Training (https://cytrain.ncrb.gov.in) among police personnel of all ranks.

- 2. It is heartening to note that a lot of requests are now being received from police personnel of all ranks for enrollment in various courses offered. However, it has been noticed that while filling online registration form, many of the police personnel are providing non-government email-ids (i.e. Gmail, Yahoo etc.) which results in rejection of their registration request as the platform only allows registration through a valid government email-id.
- 3. In view of the above, it is to intimate that States/UTs can also create their own email domain like UP Police has created 'upcyberpolice.in'. These government email-ids can also be used for other Police IT projects like CCTNS, ICJS etc.
- 4. While registration into MOOC platform with Govt. email ID can be done *suo-motto* by individual officers, non-government email-ids will also be permitted in the portal as an interim measure to continue MOOC services, provided the registration requests of individual officers are duly forwarded by CCTNS Nodal Officer of your State/UT to **nctc@ncrb.gov.in**

5. Lastly, as intimated from time to time, NCRB has launched many IT projects like CCTNS, ICJS, Crime Multi Agency Centre (CriMAC), NCTC/CyTrain Portal, National Cyber Crime Reporting Portal (NCRP) Portal etc. to provide comprehensive IT enablement to Police, and has thus shifted from **input-centric approach to output-centric approach**. I therefore, request you to popularize these projects among the field level staff and senior officers. Appropriate **Police Orders** if issued in this regard, will go a long way to promote usage of these IT services.




